Anyone who cannot work from home should continue to go into work. The DfE states that leaders are best placed to determine the workforce required to meet the needs of their pupils. You should consider whether it is possible for specific staff to undertake certain roles to work from home, while minimising disruption to face-to-face education and care.</li> </ul>	MED

Cleaning of school	Staff Pupils Others	<ul style="list-style-type: none"> <li>• All hard surfaces to be cleaned on a regular basis, this will include <ul style="list-style-type: none"> <li>➤ All door handles</li> <li>➤ All tables and chairs used by staff and pupils</li> <li>➤ Toilet flushes and regular cleaning of toilets.</li> </ul> </li> <li>• All classrooms to have spray disinfectant and where possible disposable cloths. If disposable cloths are not available use once and then put in wash.</li> <li>• Regular cleaning of surfaces will reduce the risk of spreading the virus.</li> <li>• All used cloths thrown away to be double bagged and then placed in a secure area i.e. lockable bin.</li> </ul>	MED		
Ventilation class/office	Pupils Staff	<ul style="list-style-type: none"> <li>• Identify any poorly ventilated spaces and take steps to improve fresh air flow.</li> <li>• If mechanical ventilation systems are used to draw fresh air or extract air from a room these should be adjusted to increase the ventilation rate wherever possible.</li> <li>• Ensure that mechanical ventilation systems only circulate fresh outside air and where this is not possible, in a single room supplement with an outdoor air supply.</li> <li>• Where appropriate open external windows, internal doors and external doors to improve natural ventilation.</li> <li>• If external doors are opened, ensure that they are not fire doors and are safe to do so.</li> </ul>	MED

Personal Protective Equipment Face coverings	Pupils Staff	<ul style="list-style-type: none"> <li>• Face coverings are recommended to be worn by staff and visitors when moving around the premises, in corridors and communal areas, unless exempt.</li> <li>• No pupil should be denied education if they are not wearing a face covering.</li> <li>• Face coverings do not need to be worn outdoors.</li> <li>• It is recommended that they are worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet. Ill health	Staff Pupils Others	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> <li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li> <li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>• Where contact with a pupil's parents cannot be made,</li> </ul>	MED		

		<p>appropriate procedures are followed in accordance with those outlined in governmental guidance.</p> <ul style="list-style-type: none"> <li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li> <li>• If unwell pupils and staff are waiting to go home, the disabled toilet is to be used and cleaned afterwards.</li> <li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li> <li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li> <li>• Any medication given to ease the unwell individual's symptoms, e.g. Paracetamol, is administered in accordance with the Administering Medications Policy.</li> </ul>			
<b>Primary School Pupils</b> Autumn Term Asymptomatic testing	Pupils Staff	<ul style="list-style-type: none"> <li>• There is no need for primary age pupils (those in Year 6 and below).</li> <li>• No testing is required of Primary age children.</li> <li>• Staff should undertake twice weekly home tests.</li> </ul>	MED		
PCR Test Kits	Pupils Staff	<ul style="list-style-type: none"> <li>• To be offered only to individuals who have symptoms of COVID-19 and in exceptional circumstances when they may not be able to access testing by the usual routes.</li> <li>• Parents/carers should administer tests to those age 11 and under.</li> </ul>	MED		

		<ul style="list-style-type: none"> <li>• If providing PCR tests to pupils aged 16 or under, the parents and guardians must be informed.</li> <li>• Individuals should not enter premises to collect a PCR kit.</li> </ul>			
New Variant of Concern – Omicron	Staff Pupils Others	<ul style="list-style-type: none"> <li>• All individuals who have been identified as a close contact of a suspected or confirmed case of the Omicron variant of COVID-19, irrespective of vaccination status and age, will be contacted directly and required to self-isolate immediately and asked to book a PCR test. They will be informed by the local health protection team or NHS Test and Trace if they fall into this category and provided details about self-isolation.</li> </ul>	MED		
Visitors to schools	Visitors Contractors	<ul style="list-style-type: none"> <li>• Settings are strongly encouraged to ask parents, guardians and other visitors to take a lateral flow device (LFD) test before entering the setting.</li> <li>• Face coverings are recommended to be worn by staff and visitors when moving around the premises, in corridors and communal areas, unless exempt.</li> </ul>	MED		
Positive cases	Pupils Staff	<ul style="list-style-type: none"> <li>• As of Tuesday 14<sup>th</sup> December, all contacts of someone with a positive case of COVID-19 – whether Omicron or not – should take an LFD test every day for 7 days. This includes all adults who are fully vaccinated and children aged 5-18 years and 6 months. Daily testing by close contacts will help to slow the spread of COVID-19 without meaning people have to isolate.</li> <li>• School no longer need to do contact tracing as close contacts will be identified via NHS Test and Trace.</li> <li>• School will support NHS Test and Trace when required to help identify close contacts.</li> </ul> <p><b>From 16<sup>th</sup> August 2021:</b></p> <ul style="list-style-type: none"> <li>• From 16<sup>th</sup> August 2021, children <b>under the age of 18 years and 6 months old will no longer be required to</b></li> </ul>	MED		

self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case (unless they have been identified as a close contact of a suspected or confirmed case of the Omicron variant, irrespective of vaccination status and age).

- Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.
- We would encourage all individuals to take a PCR test if advised to do so.

**Over 18 years of age**

- 18-year-olds will be treated in the same way as children until 6 months after their 18th birthday, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact.
- Continue to have a role in working with health protection teams in the case of a local outbreak. If there is an outbreak in a setting or if central government offers the area an enhanced response package, a director of United Kingdom Health Security Agency (UKHSA) or Local Public Health might advise a setting to temporarily reintroduce some control measures.

**Staff/Pupils**

- With a positive lateral flow test result should self-isolate in line with the stay at home guidance and get a PCR test to check if they have COVID-19 and continue to self-isolate.
- If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self-test and the pupils/staff can return to school as long as the

		individual doesn't have COVID-19 symptoms.			
Self-Isolation of positive cases	Pupils Child	<ul style="list-style-type: none"> <li>If a child or pupil tests positive <a href="#">they may be able to end their self-isolation period before the end of the 10 full days</a>. They can take a lateral flow device (LFD) test from 6 days after the day symptoms started and another LFD test on the following day. The second LFD test should be taken at least 24 hours later. If both these test results are negative, and the child or pupil does not have a high temperature, they may end their self-isolation after the second negative test result, and return to their education setting on day 8.</li> </ul>	MED		
Living in same household with a pupil/sibling with a positive case	Siblings Pupils Others	<p><b>From 16<sup>th</sup> August 2021</b>, you will not be required to self-isolate if you live in the same household as someone with COVID-19 (unless they have been identified as a close contact of a suspected or confirmed case of the Omicron variant, irrespective of vaccination status and age) and any of the following apply:</p> <ul style="list-style-type: none"> <li>you are fully vaccinated</li> <li><b>you are below the age of 18 years 6 months</b></li> <li>you have taken part in or are currently part of an approved COVID-19 vaccine trial</li> <li>you are not able to get vaccinated for medical reasons</li> </ul> <p>As long as the pupil/sibling is not displaying any COVID-19 symptoms, then the above guidance applies.</p>	MED		
Poor management of infectious diseases	Staff Pupils Others	<ul style="list-style-type: none"> <li>Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus.</li> <li>Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible.</li> </ul>	MED

Travel and quarantine	Staff Pupils Others	<ul style="list-style-type: none"> <li>All travellers arriving into the UK will need to isolate and get a PCR test by 'day two' after arrival. They may end their isolation once they receive a negative result. If the result is positive, they should continue to isolate and follow rules on isolation following a positive test. Unvaccinated arrivals aged over 18 will follow the existing, more onerous, testing and isolation regime.</li> <li>All red list arrivals will enter quarantine.</li> </ul>	MED		
Admitting children into school	Pupils Staff	<ul style="list-style-type: none"> <li>In most cases, parents and carers will agree that a pupil with symptoms should not attend the school, given the potential risk to others. If a parent or carer insists on a pupil attending your school, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible</li> </ul>	MED		

		<p>infection with COVID-19.</p> <ul style="list-style-type: none"> <li>Your decision would need to be carefully considered in light of all the circumstances and current United Kingdom Health Security Agency (UKHSA) or Local Public Health advice.</li> </ul>			
Admitting people into school	Pupils Staff	<ul style="list-style-type: none"> <li>Pupils, staff and other adults should not come into school if they have symptoms, have had a positive test result or have been instructed to quarantine.</li> <li>Anyone, including staff or pupils, within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow current United Kingdom Health Security Agency (UKHSA) and Local Public Health advice.</li> <li>In the case of a pupil awaiting collection, they should be taken to a room away from other pupils and supervised.</li> <li>If the member of staff is in close contact with the child, then they should wear appropriate PPE.</li> <li>A window should be opened for fresh air ventilation if possible.</li> <li>Any rooms that have been used for this purpose should be cleaned after they have left.</li> <li>As with anyone within the household, staff, pupils/ siblings should follow the UKHSA guidance for households with possible or confirmed COVID-19 infection.</li> </ul>	MED

		<ul style="list-style-type: none"> <li>• Children and young people previously considered CEV should attend school and should follow the same COVID 19 guidance as the rest of the population. They may wish to take extra precautions however.</li> <li>• If a child or young person has been advised to reduce their social contact by their specialist, due to the nature of their medical condition or treatment, rather than because of the pandemic, they should continue to follow the advice of the specialist.</li> </ul>			
Staff CEV	Staff	<ul style="list-style-type: none"> <li>• CEV people are no longer advised to shield but may wish to take extra precautions to protect themselves and to follow the practical steps set out in the CEV guidance to minimise their risk of exposure to the virus.</li> <li>• Staff should attend their place of work if they cannot work from home.</li> <li>• The school will follow DHSC updated guidance.</li> </ul>	MED

		<p>confirmed case of the Omicron variant, irrespective of vaccination status and age) if they are fully vaccinated, below the age of 18 years and 6 months, taking part in an approved COVID-19 vaccine trial or are unable to get vaccinated for medical reasons.
